

# PROCLAMATION

## NOTICE OF SPECIAL/PRIMARY ELECTION

R.C. 3501.03

The Board of Elections of Fairfield County, Ohio issues this Proclamation and Notice of Election.

A PRIMARY/SPECIAL ELECTION WILL BE HELD on Tuesday, the 2<sup>nd</sup> day of May, 2017 at the usual places of holding elections in the City of Lancaster, City of Columbus, City of Reynoldsburg, Greenfield Township, Walnut Township, Amanda-Clearcreek Local School District, Liberty Union-Thurston Local School District, Pickerington Local School District and Southwest Licking Local School District or at such places as the Board may designate, for the purpose of nominating candidates for the following offices:

City of Lancaster Fourth Ward only-Republican Primary, Council Member, vote for 1.

City of Columbus-Member of Council, vote for 3.

City of Reynoldsburg-Democratic and Republican Primary, Member of Council, vote for 3.

And for the purpose of deciding the following questions and issues:

For The City of Lancaster, 0.15% income tax, operating, maintaining municipal parks, 5 years, commencing 2018; The City Of Reynoldsburg, increase from 1.5% to 2.5% income tax, general municipal operations, maintenance, new equipment and capital improvements, commencing July 1, 2017;

Greenfield Township, additional tax levy 1.5 mills, providing and maintain firefighting facilities, equipment, and personnel, including paramedics and other emergency medical services, continuing period of time, commencing in 2017, first due 2018;

Walnut Township, additional tax levy 3 mills, providing and maintain firefighting facilities, equipment, and personnel, including paramedics and other emergency medical services, continuing period of time, commencing in 2017, first due 2018;

Amanda-Clearcreek Local School District, 1.5% income tax on earned income, 10 years beginning 2018;

Liberty Union-Thurston Local School District, additional tax levy, general permanent improvements, 3.5 mills, 5 yrs., commencing in 2017, first due in calendar year 2018;

Pickerington Local School District, additional tax levy, general permanent improvements, 3 mills for a continuing period of time, commencing in 2017, first due in calendar year 2018;

Southwest Licking Local School District, Proposed Bond Issue for the purpose of Construction, Renovating and Improving School Facilities, under the State of Ohio Classroom Facilities Assistance Program, not to exceed \$78,369,647, repaid annually over 37 yrs., and a tax levy estimated to be 6.7 mills, commencing in 2017, first due in calendar year 2018.

The polls for the election will open at 6:30 a.m., and remain open until 7:30 p.m. on election day.
