The Board of Elections of Fairfield County, Ohio, issues this Proclamation and Notice of Election.

A GENERAL ELECTION WILL BE HELD ON

TUESDAY, the 6th day of NOVEMBER 2018, at the usual place of holding elections in each and every precinct throughout the County or at such places as the Board may designate, for the purpose of choosing the following offices:

State of Ohio: Governor and Lieutenant Governor, 1 to be elected, Attorney General, 1 to be elected, Auditor of State, 1 to be elected, Secretary of State, 1 to be elected, Treasurer of State, 1 to be elected, U.S. Senator, 1 to be elected, Representative to Congress 15th District, 1 to be elected, State Senator, 1 to be elected, State Representative 77th District, 1 to be elected, State Representative 78th District, 1 to be elected, Justice of the Supreme Court (FTC 1-1-2019), 1 to be elected, Justice of the Supreme Court (FTC 1-2-2019), 1 to be elected, Judge of the Court of Appeals 5th District (FTC 2-9-2019), 1 to be elected, Judge of the Court of Appeals 5th District (FTC 2-10-2019), 1 to be elected, Judge of the Court of Appeals 5th District (FTC 2-11-2019), 1 to be elected.
